



Whereas the settlor has intended to act himself as managing trustee and has requested his wife Smt D. Kamala devi to act as a trustees and willing to be invested with the ownership of the aforesaid amount as trust fund for the purpose of carrying out the objects of the trust.

Now this deed witnesseth: -

1. That the name of the trust shall be "JESUS MARY & JOSEPH (J.M.J) CHARITABLE TRUST".
2. That the registered office of the trust shall be at George town, R.P. Plaem, Kothavalasa, Vizianagaram - 535183 and at any other place or places as may be deemed necessary by the board of trustees.

3. **OBJECTS :**

The Trust has been created for charitable purposes. The benefits of the trust extend to all persons belonging to whatever community irrespective of Caste, Creed, Religion or Nation The main objectives of the trust are to carryout the following Charitable purpose

- a) To utilize the income as well as the principal of the trust find for Charitable purpose Viz. to maintain / Organize old age homes, orphanages, educational Organizations along with or without hostels, medical relief and advancement of any other object for general public utility.
- b) To promote schools, Colleges, Vocational Training Centers and other Educational Institutional Training Centers and other Educational Institutions solely for the Educational purposes.
- c) To establish hospitals, dispensaries and other institution for the treatment of persons suffering for m illness and of persons requiring medical attentions, rehabilitation etc., existing medical for charitable etc., existing solely for Charitable purpose.
- d) To encourage give incentive and provide scholarships, medals and rewards to meritorious students on such terms and condition as the trustees may deem fit.
- e) To help unemployed men and women by way of grants like subsidies, financial assistances as may be considered fit by the trustees in charge.
- f) To do all the necessary arrangements / acts for promotion of women / girl /adult education in rural areas.
- g) To encourage and give all types of assistance for up lifting the education facilities to poor and deserved children by way books, scholarships, or any other mode decided by the trustee for m time to time.
- h) To encourage and give all types of assistance for the formers by way of technical support, all types of subsidies or any other mode decided by the trustee for m time to time.
- i) To give such allowances and donations as may be deemed fit to schools and colleges and other Charitable Institutions.
- j) To help the disabled, Physically Handicapped and Economically Backward personals by way of Medical Assistance, Educational Assistance, Financial Assistance and such other assistance as may be considered necessary.
- k) To proclaim / Publish Good News or Moral Teachings to establish Harmony, Peace in the Society at large as well as mental peace to the individual.




- l) To establish, run maintain libraries and to undertaken such other activities for the beneficial promotion and propagation of knowledge.
- m) To promote youth activities for building of their bright carrier.
- n) To publish literature promoting any object or objects of the trust and promote dissemination of useful information among concerned individuals for the purpose of furthering the cause for which the trust stand for.
- o) To organize, conduct or otherwise, assist seminars meetings, symposia or other from to exchange useful information among concerned individuals for the purpose of furthering the cause for which the trust stands for.
- p) To provide / Administer or Establish Press, Radio and T.V. Channels along with News bulletins, Periodicals for the benefit of Society at large.
- q) To do any and all other Lawful, Charitable and public utility activities for the benefit of public at large.

4. TRUSTEES :

Sree **D.A.JAGANNADHA RAO** Son of **D.SURI NAIDU** and smt **D.KAMALA DEVI** wife of **D.A.JAGANNADHA RAO** will be the first trustees of the trust and shall preside over the meetings of the trust. The Managing trustee can co-opt any other persons as a Trustee and can be appointed as the member of the Trust Board for such period and may be specified by the first trustees.

There shall not be at any time more than five trustees. One of the trustees shall always be from the family of the settlor and the managing trustee shall always be from such family member or members, unless there is no such family member who is physically and mentally fit or being fit declines to be a trustee.

The Board of trustees hereby authorized and empowered to nominate any other persons as trustee as long as trustees do not exceed five in member.

WORKING:

The Trustees shall have power to accept donations either in cash or in kind, movable or immovable properties either with or without any special conditions attached to it provided it do not contravene clause 3 herein above.

5. It shall be competent for the trustees from the time to time to frame, make and enforce all such rules, regulations and/or bye-law not inconsistent with the express provisions of this trust as the trustees may deem proper for securing the facilitating the administration and management in detailed affairs of the trust, and for convening, conducting, and regulating the meeting of the trustees and for appointing sub-committees and generally for the management and administration of the trust estate and also open time to time repeal, alter, amend, rescind or add to all such rules, resolution and bye-laws and also to pass resolution in connection with all or any of the said matters at their meeting
6. The trustees shall have power from time to time to increase or decrease the corpus of fixed property of the trust and this corpus will not be used in contravention of clause 3 herein above.
7. The trustees shall also have power to invest the Trust money in any Government securities or in any other securities approved under the Indian Trust Act and also to invest in such manner as may be directed by the Board of Trustees, and from time to time vary the investments in which the Trust funds may be invested.
8. The trust moneys shall not be invested with any private individual or firm or association of persons or body of individuals.
9. The trust may open saving or any other type of bank accounts with the scheduled banks only. The Managing Trustee will operate the same or any other person appointed by the board of trustees along with the Managing Trustee.
10. The trustees shall have power and authority to appoint or engage and at their discretion remove, dismiss to suspend due or more secretaries, treasurers supervisors, cashiers, accountants, clerks, chowkidars, attendants servants and other officials or employees and persons in permanent, temporary or special service in connection with the work of the trust, trust estate, trust funds, and trust properties as they may from time to time think fit and to determine their powers, and duties and fixed their salaries bonus or emoluments and to require security in such instance, amount as the trustees may think fit. The trustees shall also have power to found and maintain provident funds, gratuity funds, personal and other funds for any employees and make rules and regulations regarding the same.

11. The trustees shall be entitled to reimburse out of the trust estate, all expenses incurred in or about the execution of the trust or powers herein or in carrying out the trust its object and affairs of or the properties. The trustees shall be entitled to be indemnified by the Trust properties, against the consequences of all lawful acts done by the trustees in the course of and discharge of their duties as the trustees of these trusts and all costs, charges and expenses thereof.
12. For the purpose of carrying out of the objects of the trust, the trustees have power to acquire by purchase or on lease or otherwise any immovable properties of any tenure and in case of vacant land the trustees and to do all acts necessary and incidental thereto.
13. ACCOUNTS:
The account books of the trust shall be closed on 31st March of every year and Proper books of account shall be audited by a C.A. (Chartered Accountant) every Year.
14. It is mutually considered that the objects of the trust will be better achieved if the income of the trust is exempt under the Income Tax Act, In case, however a particular clause or clause will have restricted meanings so that the relevant Income Tax provisions will always have for overriding effect.
15. In the event of dissolution of the trust, there remains, after the satisfaction of all debts and liabilities any property whatsoever, the same shall be not paid to or distributed among the member of the trust and shall be given to, any other institution with similar objects and aims which has been recognized by the Income Tax Act, 1961 or other such provision as determined by the members of the majority of the trustees on or before the time to dissolution.
16. That no alteration, amendment or addition to the terms of this presents could be made without the previous approval of Commissioner of Income Tax having jurisdiction over the trust.
